- The Nomination can be made only by Individuals applying / holding units singly on his / her own behalf and Joint Applicants
 / unit holders. Non-individuals including Society, Trust, Body Corporate. Partnership Firm, Karta of Hindu Undivided
 Family, Holder of Power of Attorney cannot nominate.
- A minor can be nominated by a holder of units and in that event the Name and Address of the Guardian shall be given by the holder.
- The Nominee shall not be a Trust, Society, Body Corporate. Partnership Firm. Karta of Hindu Undivided Family or a
 Power of Attorney holder. A non-resident Indian can be a nominee subject to Exchange Control Regulations in force from
 time to time.
- 4. Nomination stands rescinded upon transfer for repurchase / redemption of units.
- Transfer of units in favour of a nominee or repayment (at NAV related Repurchase Prices) of amount of units to nominee shall be a valid discharge against the legal heir(s).
